1. Introduction	1.1	Bidders shall adhere to all the requirements of this RFP, including any amendments in Writing by ISA.
	1.2	Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by ISA. ISA is under no obligation to award a contract to any Bidder as a result of this RFP.
2. Fraud & Corruption, Gifts and Hospitality	2.1	ISA strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of ISA vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation.
	2.2	Bidders/vendors shall not offer gifts or hospitality of any kind to ISA staff members including recreational trips to sporting or cultural events, theme parks or offers of holidays, transportation, or invitations to extravagant lunches or dinners.

4. Conflict of Interests	4.1	Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. 29.Evaluation of Eligibility and Qualification	B. Eligibility and Qualification of the Bidder will be evaluated against the Minimum Eligibility/Qualification requirements specified in the Section 4 (Evaluation Criteria).
	 C. In general terms, vendors that meet the following criteria may be considered qualified: i. They are not included in the UN Security Council 1267/1989 Committee's list of terrorists and terrorist financiers. ii. A Proposal shall be rendered non-responsive at the technical evaluation stage if it fails to achieve the minimum technical score indicated in the BDS. Section 5. Terms of Reference

1. Context

ISA strives to develop and deploy cost-effective and transformational energy solutions powered by the sun to help member countries develop low-carbon growth trajectories. As a part of this, ISA has deployed demonstration projects across several regions, with the aim of showcasing viable models that can be scaled up. These demonstration projects demonstrate a range of different models such as solarizing health centres, solarizing school buildings, solar water pumps for agricultural use, solar street lights, solarizing important buildings (such as parliament buildings of countries) etc. and have been spread over different regions covering Africa, South America, Pacific Islands and Small Island Developing States.

With 24 such demonstration projects either having completed or near completion, ISA now wants to leverage this opportunity to promote the projects and their potential so that these projects can be taken up by member countries at scale. Additionally, ISA also wants to use the opportunity to project what it has been doing and the impact of its work.

Given the above, ISA is currently looking to develop high-quality communications and advocacy collateral in the form of impact stories. Key audience for this collateral will be policy makers from countries where the projects have been deployed, policy makers from other countries that ISA aims to influence. Additionally, this collateral can also be used at various forums of ISA (e.g. the General Assembly in Oct, Solar Festival in Sept etc.) to communicate the impact of ISA's work.

2. Approach

The overall approach would cover five steps.

Identifying priority projects: Given there are 24 projects that are completed, or nearing completion spread over different regions, ISA and the supporting agency will prioritize 5 most promising demonstration projects from the perspective of communications and outreach. Prioritisation will be based on: i) a representation across the thematic areas where projects fall and ii) representation across regions and iii) potential for further uptake in the host country and other countries (based on success of the project, willingness of the member country etc.).

A draft priority list is mentioned in the table below:

Identifying narratives for impact collaterals: Once the projects have been identified and prioritized, the

narrative will need to be defined presenting the critical elements of each project and its potential for greater impact. The narratives will cover the potential of the technology, the impact ISA has seen in the communities and future scale-up potential. An early perspective on these narratives is shared below:

• Solar health centers for secondary health care have been setup in remote areas of Guyana where health facilities are scarce and access to energy is very limited. As they are solarized, the health centers can run for a longer period every day and treat more patients. Additionally, regular access to electricity allows for better quality of care, advanced medical treatments, and diagnostic facilities, along with a provision for reliably storing vaccines and critical medicines which need cold storage facilities.

The demand for such solarized health centers is widespread in member countries. In the current pilot, the ISA has worked in collaboration with national Government of Guyana to provide viability gap funding, and is looking to scale up the solarization process through additional funding from the host country and additional private sector funders.

- Solarization of boarding school buildings in Kiribati has taken place in remote areas with sporadic electricity access. Due to solarization, there is access to and continuity of electricity, helping the students' study for longer periods of time in a well-lit and regulated environment. Additionally, reliable access to digital educational aids such as laptops and tablets can be given to students. Any excess energy generated during the day is stored in batteries, and used at night to provide continuous electricity to the student's hostel.
- Solar water pumps have been setup in Togo to counter the dependence on a single rainy season and associated seasonal rural to urban migration. Historically, farmers have been dependant on the rains and can only have one planting season. To augment their incomes, farmers have to migrate out and look for secondary sources of income in cities during the dry season. Having solar water pumps will allow farmers to avail of a more consistent water source and be able to plant crops more than once a year. Regular supply of water leads to healthier plants, higher yields, and variety of produce. This contributes to overall food security of the region, and also increases farm incomes in the long term.

Data collection: The data collection phase will involve combining data from the following sources:

- Any existing project information available internally.
- Any already existing communications related information / materials available with the ISA team.
- Field trips to the countries to bring the projects to life. The field trips will involve a) videos, photographs, b) interviews / FGDs with beneficiaries to understand the impact and c) interviews with important stakeholders from the countries such as policy makers / NFPs etc.
- Optionally, conducting a short survey with 20-25 beneficiaries for each project to understand the impact. In the absence of high-quality data, the survey can provide quantitative information on how the projects are impacting the beneficiaries.

Creating the collateral: Post the data collection phase, the agency will consolidate the information and create high quality, externally usable collateral. These will be in the form of videos as well as written content. Further details in the sub-section below.

Capacity building for the future: The final phase of the work will focus on a quick review of the current data sets being collected, by ISA, suggesting any additional indicators that need to be collected, and identifying indicators for ISA to collect in the future. Here the agency will also look to provide inputs on methods ISA can deploy to collect data going forward (surveys, interviews, FGDs, etc.

3. Deliverables

Must haves/ high priority:

- 1. **One five-minute master video** that captures the overall ISA projects narrative with live action footage from two locations —one school project and one health centre and photographs from the other three thematic areas.
- 2. Individual 3-minute videos that captures the narrative for each of the locations. This will have a human interest look and feel with footage of beneficiaries and details on impact generated.
- 3. **2-minute multimedia impact videos** with photo montage and impact narrative (images, text and voiceover) on **each** of the thematic areas.
- 4. Virtual Reality/ 360 degree videos on each of the projects
- 5. **Single-page infographics** on **each** of the priority projects that can be adapted for use in various formats from decks, emailers, website, social media.
- 6. **Thought leadership content** on each of thematic areas that can be used for advocacy in form of short articles and blogs, to be published externally and or on the ISA website.
- 7. Media outreach including collaterals for media outreach that can be utilised for outreach in countries of demonstration projects, and elsewhere. Media outreach will include press releases, opinion articles and media interactions/ press conferences.
