Section 2. Instruction to Bidders GENERAL PROVISIONS					
1. Introduction	1.1	Bidders shall adhere to all the requirements of this RFP, including any amendments in Writing by ISA.			
	1.2	Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by ISA. ISA is under no obligation to award a contract to any Bidder as a result of this RFP.			
2. Fraud & Corruption, Gifts and Hospitality	2.1	ISA strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of ISA vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation.			
	2.2	Bidders/vendors shall not offer gifts or hospitality of any kind to ISA staff members including recreational trips to sporting or cultural events, theme parks or offers of holidays, transportation, or invitations to extravagant lunches or dinners.			
	2.3	In pursuance of this policy, ISA (a) Shall reject a proposal if it determines that the selected bidder has engaged in any corrupt or fraudulent practices in competing for the contract in question; (b) Shall declare a vendor ineligible, either indefinitely or for a stated period of time, to be awarded a contract if at any time it determines that the vendor has engaged in any corrupt or fraudulent practices in competing for, or in executing a ISA contract.

3. Eligibility	3.1	A vendor should not be suspended, debarred, or otherwise identified as ineligible by any UN Organization or the World Bank Group or any other international Organization. Vendors are therefore required to disclose to ISA whether they are subject to any sanction or temporary suspension imposed by these organizations.			
	3.2	It is the Bidder's responsibility to ensure that its employees, joint venture members, sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by ISA.			
4. Conflict of Interests	4.1	Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Without limitation on the generality of the above, Bidders, and any of their affiliates, shall be considered to have a conflict of interest with one or more parties in this			

solicitation process, if they:

- a) Are or have been associated in the past, with a firm or any of its affiliates which have been engaged by ISA to provide services for the preparation of the design, specifications, Terms of Reference, cost analysis/estimation, and other documents to be used for the procurement of the goods and services in this selection process;
- b) Were involved in the preparation and/or design of the programme/project related to the services requested under this RFP;
- c) Are found to be in conflict for any other reason, as may be established by, or at the discretion of ISA.
- 4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to ISA, and seek ISA's confirmation on whether or not such a conflict exists. The ISA shall have the discretion to disqualify or proceed with a bidder where there is a probable conflict of interest subject to further evaluation and review of various factors such as access to sensitive information which may confer unfair advantage as against other bidders. The decision on a probable conflict of interest shall be made in the best interest of the work of the ISA.
- 4.3 Similarly, the Bidders must disclose in their proposal their knowledge of the following:
 - a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel are family members of ISA staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving services under this RFP; and
 - b) All other circumstances that could potentially lead to actual or perceived conflict of interest, collusion or unfair competition practices.

Failure to disclose such an information may result in the rejection of the proposal or proposals affected by the non-disclosure.

4.4 The eligibility of Bidders that are wholly or partly owned by the Government shall be subject to ISA's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFP, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the Proposal.

PREPARATION OF PROPOSALS

- 5. General Considerations
- 5.1 In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.
- 5.2 The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify the ISA

6. Cost of Preparation of Proposal	6.1 The Bidder shall bear any and all costs related to the preparation and/or submission of the Proposal, regardless of whether its Proposal was selected or not. ISA shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.	
7. Language	7.1 The Proposal, as well as any and all related correspondence exchanged by the Bidder and ISA, shall be Written in the language (s) specified in the BDS.	
8. Documents Comprising the Proposal	 8.1 The Proposal shall comprise of the following documents: c) Documents Establishing the Eligibility and Qualifications of the Bidder; d) Technical Proposal; e) Financial Proposal; f) Proposal Security, if required by BDS; g) Any attachments and/or appendices to the Proposal. 	
9. Documents Establishing the Eligibility and Qualifications of the Bidder	9.1 The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to ISA's satisfaction.	
10.Technical Proposal Format and Content	10.1 The Bidder is required to submit a Technical Proposal using the Standard Forms and templates provided in Section 6 of the RFP.	
	10.2 The Technical Proposal shall not include any price or financial information. A Technical Proposal containing material financial information may be declared non-responsive.	
	10.3 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by ISA, and at no expense to ISA	
	10.4 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the services and/or equipment offered as well as the cost to the ISA. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.	
11.Financial Proposals	11.1 The Financial Proposal shall be prepared using the Standard Form provided in Section 6 of the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.	
	11.2 Any output and activities described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, as well as in the final total price.	
	11.3 Prices and other financial information must not be disclosed in any other place except in the financial proposal.	

12. Proposal Security 12.1 A Proposal Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Proposal Security shall be valid up to thirty (30) days after the final date of validity of the Proposal. 12.2 The Proposal Security shall be included along with the Technical Proposal. If Proposal Security is required by the RFP but is not found along with the Technical Proposal, the Proposal shall be rejected. 12.3 If the Proposal Security amount or its validity period is found to be less than what is required by ISA, ISA shall reject the Proposal. 12.4 In the event an electronic submission is allowed in the BDS, Bidders shall include a copy of the Bid Security in their proposal and the original of the Proposal Security must be sent via courier or hand delivery as per the instructions in BDS. 12.5 The Proposal Security may be forfeited by ISA, and the Proposal rejected, in the event of any one or combination, of the following conditions: a) If the Bidder withdraws its offer during the period of the Proposal Validity specified in the BDS, or; b) In the event that the successful Bidder fails: to sign the Contract after ISA has issued an award; or to furnish the Performance Security, insurances, or other documents that ISA may require as a condition precedent to the effectivity of the contract that may be awarded to the Bidder. 13. Currencies 13.1 All prices shall be quoted in the currency or currencies indicated in the BDS. Where Proposals are quoted in different currencies, for the purposes of comparison of all Proposals: a) ISA will convert the currency quoted in the Proposal into the ISA preferred currency, in accordance with the prevailing UN operational rate of exchange on the last day of submission of Proposals; and b) In the event that ISA selects a proposal for award that is quoted in a currency different from the preferred currency in the BDS, ISA shall reserve the right to award the contract in the currency of ISA's preference, using the conversion method specified above. 14.1 If the Bidder is a group of legal entities that will form or have formed a Joint 14. Joint Venture, Consortium or Venture (JV), Consortium or Association for the Proposal, they shall Association confirm in their Proposal that: (i) they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, and submitted with the Proposal; and (ii) if they are awarded the contract, the contract shall be entered into, by and between ISA and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture. 14.2 After the Deadline for Submission of Proposal, the lead entity identified to

- represent the JV, Consortium or Association shall not be altered without the prior written consent of ISA.
- 14.3 The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Clause 15 herein in respect of submitting only one proposal.
- 14.4 The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by ISA.
- 14.5 A JV, Consortium or Association in presenting its track record and experience should clearly differentiate between:
 - a) Those that were undertaken together by the JV, Consortium or Association; and
 - b) Those that were undertaken by the individual entities of the JV, Consortium or Association.
- 14.6 Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.
- JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.

15. Only One Proposal

- 15.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture.
- 15.2 Proposals submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following:
 - h) they have at least one controlling partner, director or shareholder in common; or
 - i) any one of them receive or have received any direct or indirect subsidy from the other/s; or
 - j) they have the same legal representative for purposes of this RFP; or
 - k) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Proposal of, another Bidder regarding this RFP process;

	 they are subcontractors to each other's Proposal, or a subcontractor to one Proposal also submits another Proposal under its name as lead Bidder; or some key personnel proposed to be in the team of one Bidder participates in more than one Proposal received for this RFP process. This condition relating to the personnel, does not apply to subcontractors being included in more than one Proposal.
16.Proposal Validity Period	 16.1 Proposals shall remain valid for the period specified in the BDS, commencing on the Deadline for Submission of Proposals. A Proposal valid for a shorter period may be rejected by ISA and rendered non-responsive. 16.2 During the Proposal validity period, the Bidder shall maintain its original Proposal without any change, including the availability of the Key Personnel, the proposed rates and the total price.
17.Extension of Proposal Validity Period	 17.1 In exceptional circumstances, prior to the expiration of the proposal validity period, ISA may request Bidders to extend the period of validity of their Proposals. The request and the responses shall be made in writing, and shall be considered integral to the Proposal. 17.2 If the Bidder agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal. 17.3 The Bidder has the right to refuse to extend the validity of its Proposal, and in which case, such Proposal will not be further evaluated.
18. Clarification of Proposal	 18.1 Bidders may request clarifications on any of the RFP documents no later than the date indicated in the BDS. Any request for clarification must be sent in writing in the manner indicated in the BDS. If inquiries are sent other than specified channel, even if they are sent to an ISA staff member, ISA shall have no obligation to respond or confirm that the query was officially received. 18.2 ISA will provide the responses to clarifications through the method specified in the BDS. 18.3 ISA shall endeavor to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of ISA to extend the submission date of the Proposals, unless ISA deems that such an extension is justified and necessary.
19.Amendment of Proposals	 19.1 At any time prior to the deadline of Proposal submission, ISA may for any reason, such as in response to a clarification requested by a Bidder, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective bidders. 19.2 If the amendment is substantial, ISA may extend the Deadline for submission of proposal to give the Bidders reasonable time to incorporate the amendment into their Proposals.

20. Alternative 20.1 Unless otherwise specified in the BDS, alternative proposals shall not be **Proposals** considered. If submission of alternative proposal is allowed by BDS, a Bidder may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. ISA shall only consider the alternative proposal offered by the Bidder whose conforming proposal ranked the highest as per the specified evaluation method. Where the conditions for its acceptance are met, or justifications are clearly established, ISA reserves the right to award a contract based on an alternative proposal. 20.2 If multiple/alternative proposals are being submitted, they must be clearly marked as "Main Proposal" and "Alternative Proposal" 21. Pre-Bid Conference 21.1 When appropriate, a Bidder's conference will be conducted at the date, time and location specified in the BDS. All Bidders are encouraged to attend. Non-attendance, however, shall not result in disqualification of an interested Bidder. Minutes of the Bidder's conference will be sent to all the participants of the pre-bid conference. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the Minutes of the Bidder's Conference or issued/posted as an amendment to RFP. SUBMISSION AND OPENING OF PROPOSALS 22.Submission 22.1 The Bidder shall submit a duly signed and complete Proposal comprising the documents and forms in accordance with the requirements in the BDS. The submission shall be in the manner specified in the BDS. 22.2 The Proposal shall be signed by the Bidder or person(s) duly authorized to commit the Bidder. The authorization shall be communicated through a document evidencing such authorization issued by the legal representative of the bidding entity, or a Power of Attorney, accompanying the Proposal. 22.3 Bidders must be aware that the mere act of submission of a Proposal, in and of itself, implies that the Bidder fully accepts the ISA General Contract Terms and Conditions. https://www.isolaralliance.org/images/ISA GTB.pdf 22.4 Email submission, if allowed or specified in the BDS, shall be governed as **Email Submission** follows: a) Electronic files that form part of the proposal must be in accordance with the format and requirements indicated in BDS; b) The Technical Proposal and the Financial Proposal files MUST BE COMPLETELY SEPARATE. The financial proposal shall be encrypted with different passwords and clearly labelled. Proposals	23.2 ISA shall not consider any Proposal that is submitted after the deadline for the submission of Proposals.
24. Withdrawal, Substitution, and	24.1 A Bidder may withdraw, substitute or modify its Proposal after it has been submitted at any time prior to the deadline for submission.
Modification of Proposals	24.2 Manual and Email submissions: A bidder may withdraw, substitute or modify its Proposal by sending a written notice to ISA, duly signed by an authorized representative, and shall include a copy of the authorization (or a Power of Attorney). The corresponding substitution or modification of the Proposal, if any, must accompany the respective written notice. All notices must be submitted in the same manner as specified for submission of proposals, by clearly marking them as "WITHDRAWAL" "SUBSTITUTION," or "MODIFICATION"
	24.3 Proposals requested to be withdrawn shall be returned unopened to the Bidders, only for manual submissions. For online submissions, bids will be disregarded by ISA.
25.Proposal Opening	25.1 There is no public bid opening for RFPs. ISA shall open the Proposals in the presence of an ad-hoc committee formed by ISA, consisting of at least two (2) members.

26.Confidentiality	26.1 Information relating to the examination, evaluation, and comparison of Proposals, and the recommendation of contract award, shall not be disclosed to Bidders or any other persons not officially concerned with such process, even after publication of the contract award.
	26.2 Any effort by a Bidder or anyone on behalf of the Bidder to influence ISA in the examination, evaluation and comparison of the Proposals or contract award decisions may, at ISA's decision, result in the rejection of its Proposal and may be subject to the application of prevailing ISA vendor sanctions procedures.
27.Evaluation of Proposals	27.1 The Bidder is not permitted to alter or modify its Proposal in any way after the proposal submission deadline except as permitted under Clause 24 of this RFP. ISA will conduct the evaluation solely on the basis of the submitted Technical and Financial Proposals.

28.Preliminary Examination	28.1 ISA shall examine the Proposals to determine whether they are complete with respect to minimum documentary requirements, whether the documents have been properly signed, and whether the Proposals are generally in order, among other indicators that may be used at this stage. ISA reserves the right to reject any Proposal at this stage.
29.Evaluation of Eligibility and Qualification	B. Eligibility and Qualification of the Bidder will be evaluated against the Minimum Eligibility/Qualification requirements specified in the Section 4 (Evaluation Criteria).
	 C. In general terms, vendors that meet the following criteria may be considered qualified: i. They are not included in the UN Security Council 1267/1989 Committee's list of terrorists and terrorist financiers. ii. They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments, iii. They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required; iv. They are able to comply fully with ISA General Terms and Conditions of Contract; v. They do not have a consistent history of court/arbitral award decisions against the Bidder; and vi. They have a record of timely and satisfactory performance with their clients. vii. The consulting firm should provide credentials, through adequate references or documentation, their current local presence in the ISA focus regions. Past experience of working with ISA and/or with multilateral/international organizations will be an added advantage.
30.Evaluation of Technical and Financial Proposals	 30.1 The evaluation team shall review and evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and other RFP documents, applying the evaluation criteria, sub-criteria, and point system specified in the Section 4 (Evaluation Criteria). A Proposal shall be rendered non-responsive at the technical evaluation stage if it fails to achieve the minimum technical score indicated in the BDS. When necessary and if stated in the BDS, ISA may invite technically responsive bidders for a presentation related to their technical proposals. The conditions for the presentation shall be provided in the bid document where required. 30.2 In the second stage, only the Financial Proposals of those Bidders who achieve the minimum technical score will be opened for evaluation. The Financial Proposals corresponding to Technical Proposals that were rendered non-responsive shall remain unopened, and, in the case of manual submission, be returned to the Bidder unopened. SCOPE/ TERMS OF REFERENCE AND METHODOLOGY

1.0 About Sao Tome and Principe

Sao Tome and Principe, island country of Central Africa, located on the Equator in the Gulf of Guinea. It consists of two main islands— Sao Tome and Principe—and several rocky islets, including Rolas, south of Sao Tome Island, and Caroco, Pedras, and Tinhosas, south of Principe. Between 2010 and 2017, the percent of people below the national poverty line remained unchanged at 66 percent of the population, in line with weak economic prospects. Populations living in rural areas are disproportionally affected, in particularly when using the concept of multidimensional poverty. More than 90% of the State General Budget originates from external aid, and the debt level is also very high, at about 70% of GDP. It possesses untapped natural wealth in the form of pristine rainforests teeming with unique biodiversity. Despite its remoteness, country's favourable conditions make it an attractive destination for nature-based tourism.

Limited in size and population, the country struggles with a small and narrow economic foundation, hindering the growth of large-scale economic endeavours. Its isolation and geographical separation result in higher trade expenses and heightened susceptibility to terms-of-trade fluctuations and climate-related disruptions. Moreover, despite a GDP per capita of approximately USD 2,400 (in 2022), the nation grapples with pronounced socio-economic vulnerability, marked by elevated poverty levels (15.6% at \$2.15 per day), income inequality (Gini index of 40.7), and a scarcity of employment opportunities.¹

In 2021, the total population amounted to 223,364, with approximately 25% residing in rural areas². As of 2020, 76.6% of population has electricity access. The urban and rural electrification rate is 78.4% and 71.1% respectively.³

In 2022, the installed power capacity amounted to 47.56 MW, with a significant majority of 94% relying on diesel. The remaining 6%, equivalent to 2.65 MW, was comes from renewable sources such as hydropower and solar, with solar contributing a relatively small amount of 0.33 MW.⁴ In 2020, the total electricity generated from all sources amounted to 102 GWh. Out of this, 96 GWh was contributed by non-renewable sources, specifically oil, while rest of the 6 GWh was generated through hydro and marine.⁴

2.0 About ISA Programme (Scaling Solar Rooftops)

ISA Programme 4 "Scaling of Solar Rooftop", was launched with an objective to promote, assess potential, harmonize demand, and pool resources for rapid deployment and scaling up of Rooftop Solar (Off-Grid and Grid-Connected) in Member Countries.

Sao Tome and Principe has joined the ISA Programme No. 04 with the intention to initially develop around 1 MW of Solar Rooftop projects. In this context, ISA is looking for a competent firm / company to help Sao Tome & Principe move forward towards its stated objectives by way of understanding the policy / regulations and conducting survey & investigation of potential buildings of Sao Tome & Principe for Solar

Rooftop projects and subsequently preparing bankable DPR for the buildings enclosed at Annexure-I.

3.0 Key Deliverables

The key deliverables of the selected bidder shall be one or more of the following to enable the readiness of the Sao Tome & Principe for scaling of Solar Rooftops (SRT) projects in the country. The selected bidder is required to carry out the following activities as per the requirement of ISA while doing the assessment in Sao Tome & Principe:

- **3.1** Prepare country primary energy (supply & consumption) profile and power sector overview including generation portfolio, transmission & distribution capacity (at different voltage level), number of consumers under different categories (residential/domestic, commercial, industrial, agriculture, government and others), power demand and supply gap, power import/export scenario, electricity tariff for different category of consumers, electricity access, power and electricity consumption profile month-wise for an year etc.
- **3.2** Identification and categorisation of potential solar rooftop consumers based on service provided by them like healthcare, education, aviation, residential, industrial, government, institutions, community centre and others in consultation with the concerned ministry and associated department/agencies.
- **3.3** Execute solar rooftop assessment for the identified buildings (Annexure-1) based on the site survey and understand the readiness of the country in scaling up solar rooftop programme in the country, which includes but not limited to:
 - 3.3.1 Segmentation of identified buildings based on the services (healthcare, education, aviation, residential, institutional, community centre, industrial, government etc.) and analysis of their energy demand, operational hours, energy consumption, geolocation, prevailing electricity tariff, power supply scenario, willingness and ability to pay etc.
 - 3.3.2 Assess the capacity of existing power evacuation infrastructure and its proximity to the existing substation.
 - 3.3.3 Assess capacity & compatibility of available energy source (i.e., diesel generators) at the site and indicate the most cost-effective source or combination of sources.
 - 3.3.4 Assess the compatibility of all the identified buildings to withstand the load of solar rooftop project on roof or any other location for each site.
 - 3.3.5 Recommend the most suitable solar rooftop location(s) based on the physical assessment. This will serve as basis for the technical design of the solar rooftop project and to prioritize the location(s).
 - 3.3.6 Based on the above aspects, estimating the most optimum size of the solar rooftop projects along with optimum energy storage solutions (wherever required) for the identified location(s).
- **3.4** Assessment of financial ecosystem of the country with regard to financing of solar rooftop projects (Macroeconomic environment, business models, financing instruments, incentives schemes, portfolio of regional/national banks etc.)
- **3.5** Selected bidder shall collect all the relevant data for each site (technical, commercial & financial) and findings shall be recorded in a suitable data collection format and substantiated with site photographs duly approved by concerned administrative ministry and associated departments/agencies of the country.

- 3.6 Review the existing policies and regulations sector wise (healthcare, education, aviation, residential, industrial, government, institutions) with respect to solar energy adoption in the country and identify the gaps & challenges and provide the recommendations accordingly to scaleup the solar rooftop projects in consultation with concerned administrative ministry and associated departments/agencies of the country.
- **3.7** If the country does not have Solar Rooftop Policy, then selected bidder should prepare a suitable draft solar rooftop policy in consultation with concerned administrative ministry and associated departments/agencies.
- **3.8** Review the existing solar rooftop projects and capture learnings, best practices and reasons for successes or failures of previously implemented solar rooftop projects including plant capacity, method of implementation, timeframe, business model adopted, performance trajectory, power evacuation scenario, techno-commercial aspects and socio-economic impact of project.
- **3.9** The selected bidder shall also assist ISA in arranging training programme & workshops during country missions in country.
- **3.10** Based on the above-mentioned assessment, preparation of bankable detailed project report for each of the finalized rooftop site(s) in the country. The bankable details project report shall consist of following:
 - 3.10.1 Identification of suitable space/area, site survey details, analysis of installed electrical equipment's/appliances & connected loads, maximum demand, energy consumption profile.
 - 3.10.2 Basic engineering of proposed solar rooftop plant including layout, shadow analysis, technology selection, technical description & specification of all the components and auxiliary power requirements. The plant shall be designed in such a way that it can withstand the environmental disasters and natural calamities like storms, flood, cyclone or any others prevailing in the country.
 - 3.10.3 Techno-commercial study including design simulation & estimation of generated energy, prospective business models with its benefits, financial analysis covering financial viability, costbenefit analysis, RoE, profitability and cash flow at levelized tariff etc.
 - 3.10.4 Preparation of detailed engineering drawings for the projects including but not limited to the following:
 - Solar array layout (to be located in completely shadow free space identified during site survey).
 - Single line diagram (clearly showing and differentiating existing energy flow diagram and proposed solar power generation, distribution and integration with the existing power evacuation network).
 - Details of cable routing and termination (including complete specifications).
 - Control room equipment layout and complete equipment interconnection.
 - Location and interconnection of bi-directional energy meter.
 - A set of documents including complete specifications, warranty terms and details of traceability of all the equipment's to be supplied with the power plant.

- 3.10.5 Data regarding reduction in CO₂ emissions and fossil fuel import due to the proposed solar rooftop project(s).
- 3.10.6 Compliance of all type of statutory approvals required for the implementation of identified solar rooftop project in the country
- 3.10.7 Implementation schedule of proposed solar rooftop project(s) in the country
- 3.10.8 Manpower planning, operation & maintenance activities, risk analysis of proposed solar rooftop project(s) in the country
- 3.10.9 Conclusion & Recommendations.
- **3.11** Preparation of standard project documents like model bidding document, Power Purchase Agreement, Concession Agreement etc. (wherever required) as per the country requirement.
